Mae Polisi ac Arfer Asiantaeth yr Amgylchedd ar gyfer Gwarchod Dŵr Daear yn darparu fframwaith ar sail perygl er mwyn gwerthuso cynigion ar gyfer datblygiadau tir a allai gael effaith ar y dŵr daear sydd dan yr wyneb. Mae hyn yn cael ei atgyfnerthu gan nifer o arfau technegol sy'n caniatâu asesiad manylach o'r peryglon i ddŵr daear. Un o'r arfau hyn yw dynodi parthau gwarchod tarddleleoedd o amgylch safleoedd tynnu dŵr ar gyfer y

cyflenwad cyhoeddus a thargedau sensitif eraill.

Mae Canolfan Genedlaethol Dŵr Daear a Thir wedi'i Lygru wedi hwyluso diffinio oddeutu 1500 o barthau gwarchod i fformat cyson a dibynadwy. Defnyddiwyd modelau mathemategol megis FLOWPATH a MODFLOW/MODPATH yn y mwyafrif o achosion lle bynnag y bo digon o ddata i ganiatâu datblygu model hydroddaearegol cysniadol ar gyfer ardal. Methodology and definition of protection zones


The Environment Agency's Policy and Practice for the Protection of Groundwater provides a risk-based framework for evaluating proposals of land developments that may impact on the underlying groundwater. It is underpinned by a number of technical tools which allow more focussed assessment of the risks to groundwater. One of these tools is the designation of source protection zones around public supply abstractions and other sensitive targets.

The National Groundwater and Contaminated Land Centre has facilitated the definition of around 1500 protection zones to a reliable and consistent format. Mathematical models such as FLOWPATH and MODFLOW/MODPATH have been used in the majority of cases wherever there is sufficient data to allow a conceptual hydrogeological model to be developed for an area. The Centre advises on model applicability and co-ordinates activity in this area. In each case, three zones are defined around a particular site based on travel times of the groundwater (Zone I = 50



within specified areas, there are particular threats to groundwater. The zones themselves are monitored to ensure that they are kept up to date as

conditions change or more information becomes available, where necessary the existing model will be refined and the zone redrawn.
