The National Centre for Environmental Data and Surveillance provides opportunities for the Environment Agency and external organisations to obtain imagery of specific targets at specific times. These images are available in greater spectral and spatial detail than is available from commercial satellites. In order to make these images more widely available, a map-based interface called **Gulliver** has been designed and is available on CD-ROM. This allows the user to navigate the coastline and view images at will.

The CD-ROM is intended as a shop window on the aerial coastal survey conducted by the Environment Agency. It covers the whole coastline of England and Wales over a specific time period. It contains the following data sets for a single survey:


- full colour imagery of the coastline;
- water quality data from laboratory analysis of samples;
- metered parameters, for example salinity and temperature from the boat surveys; and
- on board chemical analysis of nutrients.

The image data presented on the Gulliver CD-ROM are collected from a small twin engine light aircraft platform using an optical system called a Compact Airborne Spectrographic Imager (CASI). This system records the brightness of the surfaces below in specific parts of the spectrum, in thin strips perpendicular to the aircraft's track. The recorded data can be processed to reveal hidden features that could never be discerned using conventional techniques. Three of the 15 spectral bands measured are presented on the CD-ROM.

The images can be cut from the viewing application and pasted into other software packages; some packages will have the capability to process the images for illustrative purposes.
