1990 BATHING WATER SURVEY

1. BACKGROUND

- 1.1 The EC Bathing Waters Directive (76/160/EEC) is intended to safeguard public health and the environment by reducing pollution of bathing waters and protecting such waters against further deterioration.
- 1.2 The Directive identifies a range of water quality standards which should be achieved in waters subject to the Directive and indicates the required monitoring frequency. These standards fall into two categories, mandatory (I) and guideline (G) standards, details of the requirements for compliance are given in Appendix 1.

The Government currently uses the E.coli and total coliforms "I" standards as the basis for determining UK compliance with the Directive. Additional microbiological "I" standards concern the occurrence of Salmonella, and enteroviruses and in Welsh Region a limited sampling programme is undertaken for these determinants. Physico-chemical "I" standard parameters are tested as indicated in Appendix 1. The occurrence of faecal streptococci is also examined and compared with the non mandatory "G" standard as no "I" standard exists for this parameter.

2. SAMPLING PROGRAMME

- 2.1 The 50 bathing waters in the Welsh region identified as falling within the scope of the Directive are displayed on Figure 1 and listed in Appendix 2. Whilst these bathing waters are not formally designated, colloquially they are referred to as such, and for brevity the term "designated" is used in this report.
- 2.2 The Government requires that these bathing waters are monitored in accordance with the requirements of the Bathing Waters Directive and the raw data reported to the Welsh Office (WO) and DOE by November of each year. This report summarises the results of the monitoring carried out during the 1990 bathing season.
- 2.3 In addition to this monitoring programme, the NRA also monitors bathing water quality at many other sites in order to establish the impact of unsatisfactory discharges and to ensure that bathing water quality does not deteriorate. The results of this monitoring programme are also reported. (Appendix 3 lists the bathing waters in this category).

3. 1990 MONITORING PROGRAMME FOR BATHING WATERS IDENTIFIED AS FALLING WITHIN THE TERMS OF THE BATHING WATERS DIRECTIVE
- 3.1 Monitoring is confined to the period 1st May - 30th September, which includes two weeks sampling prior to the DOE identified bathing season (15 May - 30th September).
- 3.2 DOE has not yet issued formal detailed implementation advice for this Directive. The monitoring programme was therefore developed using informal guidance from DOE and previous years' experience incorporating detailed comment from HMIP on specific aspects. As in previous years some assistance with sampling was provided by Local Authorities.
- 3.3 Summary data on quality collected from the 50 "designated" bathing waters are reported in Appendix 4. These results, together with those from elsewhere in the UK have been published by the Government.
- 3.4 Table 1(a) summarises E.coli and total coliform sample statistics and compliance with the "I" values for the 50 "designated" Welsh bathing waters in 1990. These results indicate that overall 35 (70%) complied with the combined standard.
- 3.5 Table 1(b) summarises Salmonella sample statistics and compliance with the "I" value for the 50 "designated" Welsh bathing waters in 1990. The results indicate that 21 bathing waters (42%) complied with the Directive standard.
- 3.6 Table 1(c) summarises enterovirus sample statistics and compliance with the "I" value for the 50 "designated" Welsh bathing waters in 1990. The results indicate that 36 (72%) complied with the Directive standard.
- 3.7 Table 1(d) summarises the compliance for all the "I" value standards for the "designated" bathing waters.
- 3.8 Table 1(e) summarises faecal streptococci sample statistics and compliance with the "G" value for the 29 "designated" Welsh bathing waters tested in 1990. This indicates that 10 (34%) complied with the standard for the Directive. The reduced number of bathing waters relates to AQC protocol problems which resulted in the results for the Northern Division having to be deleted.

4. 1990 MONITORING PROGRAMME FOR BATHING WATERS NOT IDENTIFIED UNDER THE TERMS OF THE BATHING WATERS DIRECTIVE

- 4.1 A total of 113 "non-designated" bathing waters were monitored during 1990. These results have been reported to the WO. Wherever resources allowed, monitoring was undertaken at, at least, fortnightly intervals and, as in past years assistance was provided by some Local Authorities. Appendix 5 gives summary statistical details for this monitoring programme.
- 4.2 The compliance of each of these waters with the E.coli and total coliform standards ("I" values) of the Bathing Waters Directive is shown in Table 2(a). This shows that overall 72 (64%) of the "non-designated" bathing waters complied with the combined coliform requirements of the Directive in 1990.
- 4.3 The compliance of the "non-designated" bathing waters with the faecal streptococci "G" standard of the Bathing Waters Directive is shown in Table 2(b). This shows that 10 of the 50 bathing waters tested (20%) complied with this Directive standard in 1990. As with the "designated" bathing waters AQC protocol problems resulted in the Northern Division results being deleted.

5. REMEDIAL MEASURES REQUIRED TO MEET LONG TERM OBJECTIVE

- 5.1 The long term objective is for all "designated" bathing waters to comply with the standards laid down in the Directive. In order to facilitate this an "EC Bathing Waters Improvement Strategy" has been drawn up by NRA Welsh Region to identify and prioritise the remedial works required at "designated" bathing waters to ensure compliance with the E.coli and total coliform standards by 1995. The requirements for remedial works at non-designated beaches are currently being reviewed.

Table 3 compares the compliance of the "designated" bathing waters over the period 1986 - 1990 (the assessment was carried out differently prior to 1986 and therefore cannot be included). It must be emphasised that this is considered an unreliable indication of trends due to the statistical limitations of such a small data set. In addition Table 3 indicates those bathing waters which are included in the Dwr Cymru cyf. investment programme designed to facilitate compliance by the UK with its obligations under the EC Bathing Waters Directive.

- 5.2 Table 4 gives details of remedial measures which have been completed in 1990.

6. SUMMARY

- 6.1 A total of 35 out of the 50 "designated" bathing waters complied with the E.coli and total coliform "I" standards specified in the Directive (70% of the total).
- 6.2 A total of 72 out of the 113 "non designated" bathing waters sampled in 1990 complied with the E.coli and total coliform "I" standards specified in the Directive (64% of the total).

LOCATION OF "DESIGNATED" BATHING WATER SAMPLING SITES AROUND WALES



Appendix 1

CRITERIA FOR ASSESSING COMPLIANCE WITH EC BATHING WATERS DIRECTIVE STANDARDS

1. Article 3 of the EC Directive on the quality of bathing waters (76/160/EEC) requires member states to set bathing water quality standards no less stringent than those specified as "I" values in the Annex to the Directive. Article 3 also requires member states to endeavour to observe "G" values as guidelines, whether or not there is a corresponding "I" value.
2. Article 5 sets out the detailed requirements for compliance.

For "I" value determinants:-

- a) 95% of the samples must comply with the "I" value
- b) The 5% not complying with the "I" value must not allow consecutive samples taken at statistically valid intervals to exceed the "I" value, ie. "I" value failures must be of short duration.

For "G" value determinants:-

- a) 90% of the samples must conform with the "G" value (80% in the case of total coliform and faecal coliform parameters).
- b) The 10 (or 20%) not complying with the "G" value must not allow consecutive samples taken at statistically valid intervals to not exceed the "G" value, ie. "G" value failures should be of short duration.

PART II

1. INTRODUCTION

- 1.1 Part II of the Bathing Waters Report contains information regarding compliance with the "G" standards for those parameters for which "I" standards also exist, ie E.coli and total coliforms. Compliance with the "G" standards is not mandatory but the Directive states that Member States should "endeavour" to observe them as guidelines.
- 1.2 The "G" standard compliance is specified in Appendix 1 of the main report. These standards are currently being considered by the Government as part of the forthcoming Bathing Waters (Classification) Regulations although no final decision has yet been made.

2. BATHING WATERS IDENTIFIED AS FALLING WITHIN THE TERMS OF THE DIRECTIVE

- 2.1 Table 5 summarises E.coli and total coliform sample statistics and compliance with the "G" values for the 50 "designated" Welsh bathing waters in 1990. These results indicate that overall 7 (14%) complied with the combined standard.

3. BATHING WATERS NOT IDENTIFIED AS FALLING WITHIN THE TERMS OF THE DIRECTIVE

- 3.1 The compliance of the "non-designated" bathing waters with the E.coli/total coilform "G" standard of the Bathing Waters Directive is shown in Table 6. This shows that 20 (18%) complied with this Directive standard in 1990.

4. SUMMARY
